The Vestra Wealth Grays garden was designed with a modernist feel inspired by Martin's compatriot, Eileen Gray, bringing furniture and sculpture more commonly seen in the home into a more traditional garden setting.

The garden planted with over 3,000 plants combines colour and aroma, with sharp lines and layered planting. Multi-stemmed trees and long water troughs are surrounded by an array of cool blues, creams and greens, and features the unique Susan Daniel rose.

The focal point of the garden is a 1920s pavilion featuring black lacquer and showcases some of the furniture for which Gray is so acclaimed, including the now famous 'bibendum' chair.

The show has been well attended all week, starting with the Exclusive Preview Evening on Monday 4th July which was sold out. Guests spent the evening strolling through the gardens before watching an extravagant firework display over the Long Water.
